The 2010 Summer CSA runs for 26 weeks – four weeks longer than in 2009. It begins the first week in June and ends Thanksgiving week.

We offer full shares and half shares. In a full share, we aim to provide enough vegetables each week to feed a family of four, or two vegetable enthusiasts. A half share is half as much food. If you choose to split a share with a friend, please include all email addresses above.

FULL SHARES: \$222.25 due now + additional payments of \$222 and \$222 due before 6/1/10

HALF SHARES: \$120.75 due now, additional payments of \$119 and \$119 due before 6/1/10

TERMS OF AGREEMENT

I understand that by signing below I am registering for the Frog Bottom Farm 2010 Summer CSA program. I understand that Community Supported Agriculture is a commitment between the farmers and the members and that farmers and members share the bounty and the risks of farming. I understand that I will receive a share of fresh vegetables every week for 26 weeks, beginning the first week of June and ending Thanksgiving week. I agree to pick up or arrange for pick-up of my share every week and understand that if I do not pick up my share it will be donated or composted. I understand that farming is seasonal and that the contents and quantities of my share will change throughout the season. I also understand that farming is inherently unpredictable, and that while the farmers will act in good faith to provide me with the freshest, highest quality vegetables possible, they cannot guarantee quantities or contents of shares. I understand that I can transfer ownership of my share at any point during the season but that there are no refunds.
